Policy Statement

1. Religious Education (RE) has a very high profile at Lovington Church of England Primary School and makes a significant contribution to preparing pupils for life in modern Britain. Learning activities provide for the needs of all learners. Pupils will be inspired by the subject and develop a wide range of skills such as enquiry, analysis, interpretation, evaluation and reflection, to deepen their understanding of the impact of religion on the world. Christianity is taught as a living and diverse faith, focused on the teachings of Jesus and the Church, alongside a range of religions and worldviews. Religious Education encourages pupils to learn from different religions, beliefs, values and traditions while creating a safe space for them to explore their own beliefs and questions of meaning.

Legal Requirements

2. As a Voluntary Controlled (VC) School we are required to follow the locally agreed syllabus Awareness, Mystery and Value 2019 drawn up by the Standing Advisory Council for Religious Education [SACRE].

Section 48 of the 2005 Education Act requires the inspection of religious education in schools which have a religious character. This is the Statutory Inspection of Anglican and Methodist Schools (SIAMS).

Managing the right to withdraw

3. Parents have a right by law to withdraw their children from the RE curriculum. In this event, we will undertake responsibility for their supervision regarding health and safety. Information on these arrangements is clear on our website. There will always be opportunity for parents to discuss the contents of the RE curriculum should they have concerns.

Aims of RE

4. The aims of RE are:

- a. To enable pupils to know about and understand Christianity as a living faith that influences the lives of people worldwide and as the religion that has most shaped British culture and heritage.
- b. To enable pupils to know about and understand other major world religions and world views, their impact on society, culture and the wider world, and to appreciate the diversity, continuity and change within those religions and world views
- c. To engage with challenging questions of meaning and purpose
- d. To contribute to the development of pupils’ own spiritual/philosophical convictions, exploring and enriching their own beliefs and values.

Teaching and Learning

5. In line with the Church of England RE Statement of Entitlement [2019] at Lovington CofE Primary School we aim to provide:

- a. A curriculum that enables pupils to acquire a rich, deep knowledge and understanding of Christian belief and practice
- b. A curriculum that draws on the richness and diversity of religious experience worldwide
- c. The opportunity for pupils to deepen their understanding of the religion and world views as lived by believers

- d. A pedagogy that instils respect for different views and interpretations; and, in which real dialogue and theological enquiry takes place
- e. Engaging and varied learning activities that provide for the needs of all learners, supported by high quality resources
- f. The opportunity for pupils to develop a wide range of skills including enquiry, analysis, interpretation, evaluation and reflection
- g. RE that makes a positive contribution to SMSC development and to pupils' understanding of British values
- h. An assessment process which has rigour and demonstrates progression based on knowledge and understanding of core religious concepts

Implementation

- 6. RE teaching will be implemented as follows:
 - a. RE may be taught in a 'whole class' setting but with flexibility to allow for discussion, questioning and reflection in small groups and individually.
 - b. Visits to local churches and other places of worship are encouraged
 - c. A variety of teaching approaches are encouraged: Teacher presentations, role play, drama and story telling
 - d. Questions and answer sessions, discussions and debates
 - e. Individual and group research
 - f. Photographs, pictures and maps
 - g. IT, film, podcasts, radio, websites, to research and communicate ideas.

Curriculum balance and time

- 7. Reflecting Lovington Primary School's trust deed Christianity should be the majority religion studied and should be at least 50% of curriculum time. Sufficient dedicated curriculum time, meeting explicitly RE objectives, should be given to RE. This should aim to be close to 10% but no less than 5% in Key Stages (KS) 1 and 2.

Resources

- 8. The following resources areas are available:
 - a. AMV and NATRE online resources
 - b. Understanding Christianity materials
 - c. World Religion boxes (containing books and artefacts)
 - e. NATRE (National Association of Teachers of Religious Education)

Monitoring, Evaluation, Assessment, Recording, Reporting

- 9. RE teaching will be assessed as follows:
 - a. Governors have responsibility for monitoring how the RE in the school reflects its Christian vision.
 - b. The headteacher has overall responsibility for monitoring and evaluation.
 - c. The RE subject leader will assist the headteacher by monitoring long term and medium-term plans.
 - d. The RE subject leader will assist the headteacher by monitoring RE through work scrutiny.
 - e. The subject leader will keep a file of examples of work to demonstrate continuity and progression.

- f. The subject leader will manage resources.
- g. The subject leader will endeavour to keep up to date with information, initiatives and developments in religious education and disseminate this as appropriate.
- h. The subject leader will be aware of staff development needs and encourage continuing professional development.
- i. The subject leader will facilitate the sharing of good practice.
- j. The subject leader will be responsible for drawing up an annual action plan for religious education informed by this policy.
- k. The subject leader will liaise with the Diocesan adviser with responsibility for RE.
